## CHARTER OF INCORPORATION<sup>1</sup>

BE IT KNOWN, the City of Church Hill, Hawkins County, Tennessee, being as follows:

"Beginning at a point West end of the city of Church Hill intersection U.S. Highway 11-W and Old Union road; thence a Westerly direction with U.S. Highway 11-W a distance of 800 ft. on South side of U.S. Highway 11-W; thence N. 9 W. 3690 ft. to iron pin about 250 ft. West side of Old Union road; thence N. 80-32 E. 3650 ft. along the North side of Alley Addition to a iron pin on the East side of Carters Valley road: thence running South on the East side of Carters Valley road S. 5 E. 354 ft.: S. 24 E. 100 ft.: S. 33 E. 100 ft. S. 48 E. 400 ft. S. 39 E. 100 ft. S. 28 E. 100 ft. S. 35 E. 100 ft. S. 15 E. 700 ft. S. 23 E. 262 ft. to iron pin on East side of Carters Valley Road between Marvin Jackson and John Kinkead; thence N. 81-30 E. 2050 ft. to West corner of Powers Forest Hill Subdivision; thence N. 84-15 E. 232 ft. to East side of Forest Hill road; thence S. 10' 1"; thence N. 84-15 E. 306.45'; thence S. 51-13 E. 961.6' to iron pipe on the East side of the Worley Richardson field toward railroad S. 34-20 E. 1519 ft. thence N. 45-25 E. 442 ft. to iron pin; thence N. 44 W. 146 ft.; thence N. 36-30 W. 161 ft.; thence N. 61-E. 41 ft.; thence N. 34 W. 100 ft.; thence N. 27-10 E. 282 ft.; N. 60-15 E. 817 ft. to post; thence N. 5-30 E. 705 ft.; thence N. 58-15 E. 608 ft. on the North Side of Pearl Street in the King Addition to a point beyond the King Street; thence N. 58-15 E. 712 ft.; thence N. 16-30 W. 194 ft.; N. 45-30 E. 407 ft. to Lloyds Chapel road near stump; thence from the North side of Pearl Street near a stump and on the South side of Lloyds Chapel road N. 31-E 6563 ft. to Montgomery Lane and West corner of Mount Carmel incorporation; thence S. 11-30 W. 937 ft. down Montgomery Lane to center of Cold Comfort road; thence S. 9 W. 336 ft. down the center of Cold Comfort road with Mount Carmel incorporation line; thence S. 1 E. 72 ft.; thence S. 30 E. 50 ft.; thence S. 47 E. 100 ft.; thence S. 56-30 E. 200 ft.; thence S. 44 E. 50 ft.; thence S. 40 E. 50 ft.; thence S. 27 E. 742 ft.; thence S. 22 E. 940 ft. to iron pin on the North side of 11-W Highway and the corner of Mount Carmel Incorporation; thence S. 22 E. 2200 ft. more or less to center of

Holston River; thence South West following center of river approximately 4250 ft.; thence S. 28 W. 1600 ft. toward Silver Lake road; thence S. 34-30 W. 200 ft. to iron pin South side of lane 250 ft. from Silver Lake Road; thence S. 29 W. 200 ft.; thence S. 20 W. 2200 ft. along South side of Silver Lake road; thence S. 16 W. 546 ft.; S. 43 W. 1579 ft. to corner about 250 ft. South of Bert Smith road, the one that turns South off Silver Lake road; thence N. 63-30 W. 1042 ft.; thence N. 71-30 W. 1128; thence N. 63 W. 300 ft.; thence N. 53 W. 500 ft.; thence S 37 W. 75 more or less to iron pin 312 ft. from Silver Lake Road; thence N. 23-28 W. 2665 ft. to Concrete Monument South of Dr. Clark Clinic; thence N. 84-13 W. 3493.5 ft. going through Mary Frances Price property and across Goshen Valley Road and railroad to iron pin on the Ottie Seavers property; thence N. 73-00 W. 1468 ft. to Mrs. Eldridge Hord property; thence N. 23 E. 300 ft.; S. 82-00 N. 166 ft.; N. 5-00 W. 260 ft. more or less along the West side of Minnie Pearl Alley property to South side of 11-W Highway; thence West on South side of 11-W Highway to iron pin at the starting point, a distance of 400' ."1
