

CITY OF CRAB ORCHARD, TENNESSEECHARTER OF INCORPORATION

BE IT KNOWN, that the City of Crab Orchard in the County of Cumberland, in the State of Tennessee, which is described by metes and bounds as follows, to wit:¹

Beginning at a PK nail in a railroad crosstie centered between the rails at a point 1763' Southeast of the centerline of the railroad overpass East bound lanes of I-40; thence following the centerline of Southern Railroad Northwesterly 3615 feet to a point; then 9° 30' West 5580 feet to a point; then North 15° 0' East 1980 feet to a point on Bakers Branch; thence North 76° 0' West 1540'± to East ROW of the Herbertsburg Road; thence Southerly along the East ROW of the Herbertsburg Road 3840'; thence North 33° 15' West 3440'; thence South 58° 30' West 6140'± to a point in the centerline of Old Walton Road said point being approximately 600' Northwest of the intersection of Old Walton Road and the Old Rockwood Road; thence North 55° 45' West 5660'± feet to a point in the centerline of Daddys Creek, said point being approximately 940' downstream of the centerline of the West bound lanes of I-40 bridge; thence South 56° 15' West 3620'± to a point in the South

ROW of U.S. Highway 70; thence Northwesterly along the South ROW of U.S. Highway 70 $2820^{\circ}\pm$ to the intersection with the East ROW of Deep Draw Road; thence Southwesterly along the East ROW of Deep Draw Road $3200'\pm$ to a point, said point being the intersection of the East ROW of Deep Draw Road and the centerline of Byrd Creek; thence South $63^{\circ} 0'$ East $13,340'\pm$ to a point in the centerline of Cox Valley Road, said point being approximately 2080' Southwest of the centerline intersection of Cox Valley Road and the Haley Grove Road; thence South $78^{\circ} 45'$ East 5260' to a point in the centerline of Bat Town Road; thence due East 7720' to the point of beginning.

is hereby duly and legally incorporated under Section 6-101 through 6-134, Tennessee Code Annotated, and, as such, is entitled to all the benefits and subject to all the responsibilities of the Laws of the State of Tennessee applicable to municipal corporations.
