Brief MTAS History

The Municipal Technical Advisory Service (MTAS) was established by the Tennessee General Assembly under the codified law T.C.A. § 67-6-103 in 1949 specifically to provide technical consulting services to cities and towns in Tennessee. Herb Bingham, executive director of the Tennessee Municipal League (TML), was responsible for introducing the legislation and getting it passed into law.

Originally, MTAS was established in the UT Division of University Extension with an advisory council that consisted of Bingham and professors in the subject areas of business management, sociology, law, engineering, political science. Today, MTAS resides in the UT Institute for Public Service and is staffed by experts in municipal government.

The original legislation best describes the MTAS purpose:

"It shall be used for studies and research in municipal government, publications, educational conferences and attendance thereat and in furnishing technical consultative and field services to municipalities in problems related to fiscal administration, accounting, tax assessment and collection, law enforcement, improvements in public works, and in any and all matters relating to municipal government."

Over time, MTAS expanded its services beyond consultation with the establishment of an extensive municipal information library, fee-based codification services, and an extensive training program for municipal officials and employees in order to enhance their performance and improve local governance.

From a staff of five in the early days to a staff of over 50 individuals today, MTAS continues to fulfill its mission through a diverse range of consultative services, educational programs and information services aimed at equipping municipalities with the necessary tools and knowledge to improve the lives of those they serve.

State-Shared Revenue Estimates for Fiscal Year 2024-25

Cities throughout Tennessee receive revenues from the state each month in the form of state-shared revenues. Various state laws prescribe how these shared revenues are calculated and disbursed. Gas and Motor Fuel tax is divided into dollars that fund the 1) State Street Aid Fund and the 2) General Fund as a Special Petroleum tax.

As the 2024-25 budget season approaches it is important to know an estimate of state-shared revenues to prepare the most accurate budget possible. The estimates below can be used for budget preparation and will be updated monthly as actual amounts of state-shared revenue are disbursed to cities and towns are made available. At the time of this publication six months of actual disbursement data is known. There is a two-month gap between when dollars are collected from consumers and when they are actually sent to cities.

Revenues are disbursed on a per capita basis. To calculate a current estimate by type, simply multiply the certified population by the per capita amount shown below:

Cities should be aware that economic conditions and other factors can affect revenue collections, therefore these numbers should be viewed as estimates and as additional monthly actual collections are known they will be updated.

Is Your City Ready for AI?

Artificial Intelligence (AI) may seem like a recent development given its frequent coverage in the news. However, local governments around the country are already leveraging AI to enhance their operations in numerous ways. For instance, machine learning algorithms for traffic management can predict and control traffic flow. reducing congestion and improving road safety. Natural Language Processing (NLP) can automate customer service functions, ensuring constituents receive prompt responses to their queries at any time of day. Predictive analytics can be used to forecast civic issues such as infrastructure requirements or potential public health crises before they escalate. Facial recognition software can assist law enforcement agencies in criminal investigations. The potential uses for AI certainly seem endless!

While AI is exciting, it's crucial to exercise caution with such applications due to potential privacy issues and the risk of bias embedded in AI systems1. Potential uses of AI and actual implementation will also vary among cities depending on resource availability, specific needs and policy considerations.

One way to demystify AI is through training. We offer a range of free online courses on AI in K@TE, our learning management system.

TREEDC RECOGNIZES CONTRIBUTIONS OF JOHNSON, DEEM AND NORRIS


