2013 Certified **Municipal Finance Officer Program Now Open Enrollment**

Each CMFO class will qualify as eight hours of continuing professional education (CPE) for certified public accountants or seven hours if no exam is taken. MTAS has also received approval from the Tennessee State

Board of Accountancy to award five hours of CPE for taking the CMFO exams. The state law allows participants to test out on all classes except Government Environment for which attendance is required.

# Lakeland Joins MTAS' Benchmarking Project

T ENNESSEE MUNICIPAL B ENCHMARKING P ROJECT As a part of its ongoing expansion efforts, the Tennessee Municipal Benchmarking Project (TMBP), a project of the UT Municipal Technical Advisory Service (MTAS) has added a fourth new city this year to its list of participants. With the entry of the city of Lakeland, TMBP is bigger than it has ever been in its 11-year history. It now boasts a membership of 14 participating municipalities.

TMBP Project Coordinator Sarah Young conducted an on-boarding session in Lakeland to orient the city's staff to the project. She briefed participants on the project timeline, measures collected in the project and forms used to collect the data. MTAS staff plan to arrange additional follow-up calls to assist Lakeland's staff with its first year of TMBP data collection.

Lakeland is no stranger to performance measurement initiatives, having participated in the nationwide International City Managers Association (ICMA) project earlier this year. Joining the TMBP will give the city a chance to compare its performance to Tennessee cities, specifically.

"In our mission to deliver Lakeland residents the highest quality services at the best possible value, the city is participating in the MTAS Benchmarking program," said Executive Coordinator Thad Jablonski. "This continues the city's ongoing efforts to identify key performance benchmarks and measure performance over time. We look forward to working with MTAS and other cities in the project to share information on service area performance and local practices."

# MTAS Advisory Committee Attends Fall 2012 Retreat

On October 25-26, the MTAS Advisory Committee held its third meeting of the year to hear updates and consider issues regarding MTAS. The MTAS advisory committee is composed of representatives from cities and related associations. The committee provides guidance and feedback from the customer perspective on both short-term and long-term strategic initiatives of the agency and answering the question, "Are MTAS services meeting the current and emerging needs of Tennessee towns and cities?"

The meeting was led by Committee Chair Mike Walker, city manager in Brentwood, and MTAS Executive Director Jim Thomas. Jim presented updates to the committee on ongoing work as well as new things on the horizon for MTAS. MTAS staff provided brief updates from each program within the agency such as IT, consulting, research and information and training. Also on the agenda for this meeting were presentations from each of the other IPS agencies (Naifeh Center, CTAS, CIS and LEIC.) Advisory committee members commented that this portion of the agenda opened their eyes to the depth and breadth of the resources available from the IPS agencies. One city manager mentioned an interest in LEAN management practices and that he would be following up with CIS on that methodology.

The committee was also treated to a presentation by Dr. David Folz, director of the master's of public policy and administration program at UTK and longtime collaborator with MTAS on many services to cities. Dr. Folz presented a profile of the current student, and overview of the MPPS curriculum, competencies for future public administrators, as well as a look at the possible career interests of these students. Dr. Folz also discussed the MTAS contributions to the MPPA program through the Public Financial Management course. MTAS consultants modeled the curriculum after the Certified Municipal Financial Manager course. The course has been a success and will be repeated in the upcoming spring semester 2013.

The meeting was held at Fall Creek Falls State Park near Pikeville. The fall colors, brisk temperatures and blue skies provided a perfect backdrop for this collegial group to conduct its business and get to know each other, and the business of MTAS, better.

The German Energy Agency develops flagship projects for German renewable energy in the field of photovoltaics, solar cooling and solar thermal energy. All of the solar roofs developed by the German Energy Agency are designed as public private partnerships and co-financed by the German Federal Ministry of Economics and Technology. Since 2004, 40 projects have been developed in Australia, Brazil, Canada, China, France and South Korea and many other countries.

Attendees heard presentations from Vis-Solis and their dual axis solar technology. TREEDC also gave an overview of the TREEDC International Exchange program that is designed to cultivate technology and informational exchange among TREEDC's business, colleges, local government and state agency members with international renewable energy related counterparts. Many Tennessee renewable energy firms conduct business overseas and the mayors of TREEDC desire to help advance their business plans by engaging other countries to help start similar grassroots outreach endeavors.

Jessica Klein, renewable energy manager for the German Energy Agency, gave a detailed presentation regarding the developmental goals in the United States. They hope to have a solar inauguration in Washington, D.C., sometime in 2013. Cortney Piper, president of Piper Communications, helped organized the statewide tour to help promote more efficient solar technology.

During the TREEDC-Memphis Forum held recently, TREEDC member Pathway Lending announced a commitment of \$10 million through the Sustainable Communities initiative to provide financing for energy efficiency improvements for businesses located in Memphis and Shelby County. This initiative will help more area businesses be able to implement energy efficiency projects and achieve long-term energy cost savings. This loan program is a publicprivate partnership between TREEDC Mayors AC Wharton, Jr. and Mark Luttrell, the Joint Offices of Sustainability, and Pathway Lending. According to Memphis and Shelby County Sustainability Director Paul Young, this partnership is also designed to provide the necessary tools and resources to motivate individuals in the community to make their homes and businesses more energy efficient.

Christian Brothers University (CBU), TREEDC Schools Coordinator/Memphis Councilman Dr. Edumund Ford, Jr., Mirimichi Green and the University of Tennessee Municipal Technical Advisory Service (MTAS) partnered with TREEDC to organize the third annual Memphis community-wide forum. Clean energy topics explored included compressed natural gas, solar energy, solid wastes to clean energy and hydrokinetic energy. Eighty-one attendees also heard from PHG Energy regarding their wastewater sludge gasification project with TREEDC Member City of Covington. CBU Associate Professor Dr. Ben Jordan discussed sustainability initiatives.

TREEDC Founding Member Mirimichi Green is a sister company to Mirimichi Golf Course owned by entertainer and film star Justin Timberlake. Mirimichi Green has developed and implemented comprehensive and advanced sustainability programming and is one of the most recognized and award-winning golf courses in the world for these efforts.

TREEDC is a statewide grassroots organization of 88 cities and counties promoting the economic benefits of renewable energy for Tennessee communities. TREEDC was formed by the University of Tennessee President Emeritus Dr. Joe Johnson in 2008. The organization recently received the Governor's Award on Energy Resources and Leadership.

Take your balanced annual budget for the general fund, and create a monthly budget. With a little effort, you can create a monthly cash flow spreadsheet that is based on your city's actual historical trends of revenues and expenditures. You will use a spreadsheet in this class with your own budget data, so you will leave with your own cash flow forecasting data. Bring a laptop computer with Excel on it, if you have one available. This advanced knowledge enables the finance officer to better manage cash shortages through borrowing or perhaps utilize an available fund balance. On the investment side, idle funds may be invested longer because it can be accurately predicted when they will be needed.

MTAS Finance and Accounting Consultant Al Major will instruct the class which is recommended for municipal finance officers and those who are seeking CMFO continuing education credit. All classes are from 8:30 a.m. to 12:30 p.m.


