ADMINISTRATIVE HEARING OFFICER TRAINING MAY 21 | NASHVILLE | TML CONFERENCE ROOM

The Administrative Hearing Officer program provides training for both code officials and those seeking to become an AHO. Successful completion of this training authorizes certain participants to serve as municipal AHOs pursuant to Public Chapter No. 1128 of the 2010 Public Acts. Pursuant to this law, a municipality can, via ordinance, create an administrative hearing office with jurisdiction to hear violations of certain locally adopted codes. The law also allows a municipality, through its AHO, to levy fines for such violations in excess of \$50.00.



The We Regret to Inform You training module provides the resources to offer a death notification with professionalism, dignity and compassion. The course takes about 45 minutes to
