Captain Barry Brady, A Legacy of Lives Saved

Eligible Tennessee firefighters will receive an additional benefit from the 112th General Assembly effective July 1, 2022. The benefit is in the form of two additional cancers being added to Tennessee Code Annotated (T.C.A.) § 7-51-201(d) Cancer Presumption Law (Barry Brady Act). The 111th General Assembly passed the original legislation in 2019, establishing certain cancers to potentially be considered a workplace illness for eligible firefighters. This act is legacy legislation named for Sparta Fire Captain Barry Brady.

Brady leaves a great legacy of being a dedicated public safety public servant. He not only served the residents and visitors of Sparta, but his efforts in fire service professional associations was impactful across our state. Brady found himself battling late-stage colon cancer, but he never lost his passion for public service. His unwavering love and support to his wife Dawn, family and members of the fire service inspired many to get this legislation passed.

Brady was, like many other firefighters, a hometown hero. He used his hands to touch and save many lives in and around Sparta. Through this legislation, Captain Brady's legacy continues, saving the lives of brother and sister firefighters from across our state.





The act passed by the 111th General Assembly originally covered four cancers including colon cancer, non-hodgkin's lymphoma, skin cancer and multiple myeloma. The 112th General Assembly amended the act adding two additional cancers including leukemia and testicular cancer.

Firefighters owe a debt of gratitude to the members of the 111th and 112th General Assembly and Governor Bill Lee for recognizing the inherent dangers associated with the profession of firefighting and passing legislation to help fight these covered cancers.

TREEDC Hosts Philippines Department of Agriculture Officials

TREEDC's international collaborations are reaching new heights. Recently, TREEDC stakeholders, member universities (the University of Tennessee, Middle Tennessee State University, Tennessee Tech University and the University of Tennessee Martin) and the Philippines Department of Agriculture gathered for a week to promoting international agriculture and economic development. In attendance were TREEDC International Affairs Director and Urdaneta City University President Dr. April Alcazar; Philippines Undersecretary for the Department of Agriculture Roldan Gorgonio; and Philippines Senior Advisor to Secretary of the Department of Agriculture Dennis Layug.

The delegation explored ways that TREEDC member universities can strategically align with international students and clean energy stakeholders. The Philippine delegation also toured Hico America's manufacturing plant and the University of Tennessee Extension Services office in Sequatchie County.

The highlight of the trip was visit to the Tennessee State Legislature to join the Committee on Agriculture during its sessions. Logan Matthews, representative of the TREEDC Tennessee Flood-Ready Coalition, also met the delegation. As a result of the trip, a memorandum of understanding was signed between the

Rural Energy Pilot Program Offered By the USDA

The <u>Rural Energy Pilot Program</u> (REPP) offers grant assistance to Rural Energy Community Partnerships (RECPs) to develop renewable energy that can meet the nation's energy needs and combat emissions while prioritizing environmental justice, racial equity and economic opportunity. REPP partnerships may be comprised of, but are not limited to, non-profit entities, state and local entities, tribal entities, municipalities and other public bodies.

Funding may be used to support community energy planning, capacity building, and technical assistance; community efficiency and weatherization; and installation of communityscale renewable energy technologies and systems. Eligible rural areas include any area that is not:

- a city or town that has a population of greater than 50,000 inhabitants or
- the urbanized area contiguous and adjacent to such a city or town, as defined by the U.S. Bureau of the Census using the latest decennial census of the U.S.

Selected projects will receive up to 80 percent of total eligible costs, not to exceed \$2 million for grant terms of three years. Applicants are encouraged to review all application materials found in the Federal Register Notices information at the <u>REPP Notice of Funding Opportunity</u> webpage.

The deadline to submit full applications will be due July 18, 2022. Review the Letter of Intent requirements, how to apply, and other important information at the <u>REPP webpage</u>. <image>
