#### IN JUNE OF 2014 THE MUNICIPAL TECHNICAL ADVISORY SERVICE

received a call for assistance from the city of Memphis Division of Public Works to help develop a system to track and repair potholes and utility cuts in Memphis city streets.

MTAS Public Works Consultant John Chlarson contacted Keith Groves from the Center for Industrial Services because of CIS' experience in process improvement. At an



initial meeting with the city all parties agreed that this was an ideal opportunity for applying Kaizen principles to develop new operating procedures for Memphis Public Works street repair crews.

The UT team of John Chlarson, Michael Codega, Keith Groves and Ronnie Neill spent two weeks prior to the kaizen event conducting field research and interviews in Memphis to collect data and gain an understanding of what was actually taking place with the street repairs process.

The UT team along with seven people from Memphis Public Works then spent four days in the improvement process which included verifying the findings, mapping the current process, identifying opportunities and gaps, and developing a new procedure.

The team developed 10 recommendations and procedures that should result in an improved process for repairing potholes and utility cuts in Memphis streets.

## FEMA Offers Respiratory Protection Course



**ONE OF THE MOST FREQUENTLY FOUND VIOLATIONS BY TOSHA INSPECTORS** when visiting fire departments is a lack of, or an inadequate in some regard, respiratory protection program. A respiratory protection program is required by OSHA under 29 CFR 1910.134.

Respiratory Protection: Program Development and Administration RP / PER-263

Respiratory Protection: Program Development and Administration is a three-day course which provides the necessary information to develop, implement, administer, and properly sustain a respiratory protection program. Along with other Federal regulations, all aspects of Respiratory Protection, 29 Code of Federal Regulations (C.F.R.) § 1910.134 is discussed. Students can use the information provided during the course to build a respiratory protection program that complies with the laws and regulations regarding specific emergency response actions.

To be eligible to attend RP, candidates must be an employer-designated respiratory protection program administrator with requisite knowledge of the subject and purpose of the course content.

## MTAS Updates Municipalities on Legislative Issues

IN JULY, THE UNIVERSITY OF TENNESSEE MUNICIPAL TECHNICAL ADVISORY SERVICE (MTAS) in cooperation with the Tennessee Municipal League (TML) facilitated training on the 2014 Tennessee State Legislature's session. With over 160 participants, serving as elected and appointed municipal officials and attorneys, these sessions were conducted in Kingsport, Knoxville, Franklin and Jackson.

These interactive sessions covered 26 areas and 124 individual legislative acts. Areas of interest included: alcoholic beverages, animals, authorities, boards, commissions, codes enforcement, contracts, crime and criminal procedure, economic development, education, elections, environment, finance, fire, firearms, general government, land use, planning and zoning, landlords and tenants, law enforcement, motor vehicles and traffic, personnel, records, state government, taxation, tort liability, transportation, and utilities.

The intended purpose of these sessions was to educate municipal officials regarding changes in law impacting Tennessee cities.
