That a certain document, one (1) copy of which is on file in the office of the Milan City Recorder, being marked and designated as the International Building Code,² 2018 edition including Appendices B, C, H, and I, as published by the International Code Council, be and is hereby adopted as the Building Code of the City of Milan, Tennessee, for regulating and governing the conditions and maintenance of all property, buildings, and structures; by providing the standards for supplied utilities and facilities and other physical things and conditions essential to ensure that structures are safe, sanitary, and fit for

- Fire protection, fireworks, and explosives: title 7.
- Planning and zoning: title 14.
- Streets and other public ways and places: title 16. Utilities and services: titles 18 and 19.

occupation and use; and the condemnation of buildings and structures unfit for human occupancy and use and the demolition of such structures as herein provided; providing for the issuance of permits and collection of fees therefor; and each and all of the regulations, provisions, penalties, conditions, and terms of said building code on file in the office of the Milan City Recorder are hereby referred to, adopted, and made a part hereof, as if fully set out in this chapter, with the additions, insertions, deletions, and changes, if any, prescribed in § 12-102 of this chapter. Pursuant to authority granted by <u>Tennessee Code Annotated</u>, §§ 6-54-501 through 6-54-506 and for the purpose of providing practical minimum standards for the safeguarding of persons and of buildings and their contents from hazards arising from the use of electricity for light, heat, power, radio, signaling, or for other purposes, the <u>National Electrical Code</u>,² 1993 edition, as prepared by the National Fire Protection Association, is hereby adopted and incorporated by reference as a part of this code and is hereinafter referred to as the electrical code. 12-302. <u>Available in building inspector's office</u>. It is a misdemeanor for any owner or his agent to rent or lease to another any dwelling unit in the City of Milan, Tennessee, until and unless such dwelling unit conforms to the housing code and the mayor issues a certificate to that effect.

It is also a misdemeanor for any person to lease, or rent from another, or occupy, any dwelling unit unless said dwelling conforms to the housing code and the mayor issues a certificate to that effect.

It is also a misdemeanor for any person, firm or corporation to furnish or connect or turn on any utilities such as gas, water, or electricity to the occupant of any dwelling which has been vacated just prior to the occupancy by such occupant unless said dwelling conforms to the housing code and the mayor has issued a certificate that said dwelling conforms to said code. The mayor and the building inspector are hereby authorized and directed to inspect all vacated buildings and if same comply with the provisions of the housing code they are to execute a certificate to that effect and to notify the various utility purveyors. If said dwelling does not conform to the housing code then they shall notify the owner thereof, or his agent, of such deficiencies.

Any person, firm, or corporation violating the provisions of this section shall be guilty of a misdemeanor and fined under the general penalty clause for the Milan Municipal Code. In addition, the mayor is hereby authorized and directed to file suit for an injunction to require compliance with this chapter. (1973 Code, § 4-505)

CHAPTER 4

RESIDENTIAL ENERGY EFFICIENCY

SECTION 401 GENERAL

401.1 Scope. This chapter applies to residential buildings. 401.2 Compliance. Projects shall comply with Sections 401, 402.4, 402.5, and 403.1, 403.2.2, 403.2.3, and 403.3 through 403.9 (referred to as the mandatory provisions) and either:

- 1. Sections 402.1 through 402.3, 403.2.1 and 404.1 (prescriptive); or
- 2. Section 405 (performance).

2. Section 405 (performance). 401.3 Certificate. A permanent certificate shall be posted on or in the electrical distribution panel. The certificate shall not cover or obstruct the visibility of the circuit directory label, service dis-completed by the builder or registered design profossional. The certificate shall list the predominant *R*-values of insulation installed in or on ceiling/roof, walls, foundation (slab, basement wall, criawlspace wall and/or floor) and ducts outside condi-tioned spaces; *U*-factors for fenestration and the solar heat gain value for each component, the certificate shall list the value cover-ing the largest area. The certificate shall list the types and efficien-

cies of heating, cooling and service water heating equiprment. Where a gas-fired unvented room heater, electric furnace, or base-board electric heater is installed in the residence, the certificate shall list "gas-fired unvented room heater," "electric furnace" or "baseboard electric heater," as appropriate. An efficiency shall not be *listed* for gas-fired unvented room heaters, electric furnaces or electric baseboard heaters.

SECTION 402 BUILDING THERMAL ENVELOPE

402.1 General (Prescriptive).

402.1.1 Insulation and fenestration criteria. The building thermal envelope shall most the requirements of Table 402.1.1 based on the climate zone specified in Chapter 3.

402.1.2 *R*-value computation. Insulation material used in layers, such as framing cavity insulation and insulating sheathing, shall be summed to compute the component *R*-value. The manufacturer's settled *R*-value shall be used for blown insulation. Computed R-values shall not include an R-value for other building materials or air films.

12-701. International Mechanical Code adopted. That a certain document, one (1) copy of which is on file in the office of the Milan City Recorder, being marked and designated as the International Mechanical Code,¹ 2018 edition, including Appendix A, as published by the International Code Council, be and is hereby adopted as the Mechanical Code of the City of Milan, Tennessee, regulating and governing the design, construction, quality of materials, erection, installation, alteration, repair, location, relocation, replacement, addition to, use or maintenance of mechanical systems as herein provided; providing for the issuance of permits and collection of fees therefor; and each and all of the regulations, provisions, penalties, conditions and terms of said mechanical code on file in the office of the Milan City Recorder are hereby referred to, adopted, and made a part hereof, as if fully set out in this chapter, with the additions, deletions, and changes, if any, prescribed in § 12-702 of this chapter. (as added by Ord. #2006-04, June 2006, and amended by Ord. #12-05, April 2012, Ord. #2018-1, March 2018 Ch7 6-20-19, and Ord. #2020-14, Nov. 2020 Ch8_01-11-22)

12-801. International Property Maintenance Code adopted. The International Property Maintenance Code, 2006 edition, as published by the International Code Council, is hereby adopted as the Property Maintenance Code of the City of Milan, Tennessee, and made a part hereof as if fully set out herein verbatim, for regulating premises, structures, equipment and facilities for light, ventilation, space, heating, sanitation, protection from the elements, life safety, safety from fire and other hazards, and for safe and sanitary maintenance, and to regulate the responsibilities of owners, operators and occupants, the occupancy of existing structures and premises, and for administration, enforcement and penalties.
