CHAPTER 1

POLICE AND ARREST

SECTION

- 6-101. Policemen subject to chief's orders.
- 6-102. Policemen to preserve law and order, etc.
- 6-103. Policemen to wear uniforms and be armed.
- 6-104. When policemen to make arrests.
- 6-105. Policemen may require assistance.
- 6-106. Disposition of persons arrested.
- 6-107. Police department records.
- **6-101.** Policemen subject to chief's orders. All policemen shall obey and comply with such orders and administrative rules and regulations as the police chief may officially issue. (1978 Code, § 1-401)
- **6-102.** Policemen to preserve law and order, etc. Policemen shall preserve law and order within the town. They shall patrol the town and shall assist the city court during the trail of cases. Policemen shall also promptly serve any legal process issued by the city court. (1978 Code, § 1-402)
- 6-103. <u>Policemen to wear uniforms and be armed</u>. All policemen shall wear such uniform and badge as the mayor shall authorize and shall carry a service pistol and billy club at all times while on duty unless otherwise expressly directed by the chief for a special assignment. (1978 Code, § 1-403)
- **6-104.** When policemen to make arrests. Unless otherwise authorized or directed in this code or other applicable law, an arrest of the person shall be made by a policeman in the following cases:

Traffic citations, etc.: title 15, chapter 7.

- (1) Whenever he is in possession of a warrant for the arrest of the person.
- (2) Whenever an offense is committed or a breach of the peace is threatened in the officer's presence by the person.
- (3) Whenever a felony has in fact been committed and the officer has reasonable cause to believe the person has committed it. (1978 Code, § 1-404)
- **6-105.** Policemen may require assistance. It shall be unlawful for any person willfully to refuse to aid a policeman in maintaining law and order or in making a lawful arrest when such a person's assistance is requested by the policeman and is reasonably necessary. (1978 Code, § 1-405)
- **6-106.** Disposition of persons arrested. Unless otherwise authorized by law, when a person is arrested he shall be brought before the city court for immediate trial or allowed to post bond. When the city judge is not immediately available or the alleged offender is not able to post the require bond, he shall be confined. (1978 Code, § 1-406)
- **6-107.** Police department records. The police department shall keep a comprehensive and detailed daily record in permanent form, showing:
- (1) All known or reported offenses and/or crimes committed within the corporate limits.
 - (2) All arrests made by policemen.
- (3) All police investigations made, funerals convoyed, fire calls answered, and other miscellaneous activities of the police department. (1978 Code, § 1-407)

CHAPTER 2

WORKHOUSE

SECTION

- 6-201. County workhouse to be used.
- 6-202. Inmates to be worked.

- **6-201.** County workhouse to be used. The county workhouse is hereby designated as the municipal workhouse. (1978 Code, § 1-601)
- **6-202.** <u>Inmates to be worked</u>. All persons committed to the workhouse shall be required to perform such public work or labor as may be lawfully prescribed for the county prisoners. (1978 Code, § 1-602)
- **6-203.** Compensation of inmates. Each workhouse inmate shall be allowed five dollars (\$5.00) per day as credit toward payment of the fines assessed against him. (1978 Code, § 1-603)

CHAPTER 3

POLICE DEPARTMENT

SECTION

6-301. County sheriff's department to enforce municipal ordinances.

6-301. County sheriff's department to enforce municipal ordinances. The Sheriff's Department of Perry County shall enforce the municipal ordinances of the city according to the terms of the agreement entered into between the city and the County of Perry, the Sheriff's Department of the County of Perry, and the Perry County Court of General Sessions, pursuant to Tennessee Code Annotated, §§ 8-8-201(34), 12-9-104 and 16-15-501.¹ (Ord. #88-1, ____, modified)
