# CHAPTER 1

# **BOARD OF WATERWORKS AND SEWERAGE COMMISSIONERS**

# SECTION

2-101. Membership; bonds required; powers and duties.

**2-101.** <u>Membership</u>; <u>bonds required</u>; <u>powers and duties</u>.<sup>1</sup> (1) The custody, administration, operation, maintenance and control of the town's waterworks and sewerage system is hereby vested in a board of waterworks and sewerage commissioners.

(2) It shall consist of five (5) members appointed by the board of mayor and aldermen in accordance with the provisions of <u>Tennessee Code Annotated</u>, title 7, chapter 35, part 4.

(3) The members of the board of waterworks and sewerage commissioners shall give bonds in the amount of \$1,000.00 each.

(4) The board of waterworks and sewerage commissioners shall have such powers and duties as are authorized and prescribed by <u>Tennessee Code</u> <u>Annotated</u>, title 7, chapter 35, part 4. (1983 Code, § 13-101)

**2-201.** <u>Creation</u>. In accordance with <u>Tennessee Code Annotated</u>, § 11-24-103(b)(1), there is hereby established the Oneida Recreation Advisory Board. (Ord. #604, April 1992)

**2-202.** <u>Authority</u>. The powers of the Oneida Recreation Board shall be advisory only. The recreation board shall prepare reports and provide recommendations to the board regarding proposed changes or improvements to Oneida's recreation programs and facilities. (Ord. #604, April 1992)

**2-203.** <u>Membership</u>. The Oneida Recreation Board shall consist of five (5) members, as appointed by board of mayor and aldermen. The terms of membership shall be for three (3) years. The initial terms of office shall be established so that at least one (1) term shall expire each year. (Ord. #604, April 1992)

**2-204.** <u>Officers</u>. The board shall elect a chairman, vice chairman, and secretary from its membership. The chairman shall preside at all meetings, and in his absence, the vice chairman shall preside. The secretary shall be responsible for keeping the minutes and maintaining the board's records. (Ord. #604, April 1992)

**2-205.** <u>Meetings</u>. The board shall meet at a regular time and place, as determined by the board. All meetings shall be open to the public. (Ord. #604, April 1992)
