/ AIRPORT MANAGEMENT CONTRACT SPRINGFIELD-ROBERTSON COUNTY AIRPORT /

AGREEMENT entered into this 23rd day of March, between Walter McCauley , party of the first 1992, "MANAGER" and the hereinafter referred to as part, SPRINGFIELD-ROBERTSON COUNTY AIRPORT BOARD, party of the second part, hereinafter referred to as "OWNER";

WITNESSETH:

Owner appoints Manager and Manager accepts management of the Springfield-Robertson County Airport located in Robertson County, State of Tennessee, management to continue for a period of two years beginning on the 1st day of April , 1992, and ending on the 31st day of March , 1994, unless sooner terminated as herein provided.

Manager shall have exclusive management of Airport as agent of the Owner and as such agent shall provide all adequate arrangements and equipment, at the expense and subject to the approval of the Owner, for the operation and maintenance of said Airport, together all its facilities and appurtenances; shall provision for the leasing of ground and storage space for planes and other similar and dissimilar equipment of parties desiring to use said Airport; shall collect for, account to and turn over to the Owner Secretary/Treasurer at least monthly, all sums collected on the owners behalf. All disbursements and/or expenditures shall be done by official Airport Board consecutively numbered Purchase Order forms signed by the Manager, Board Chairman, and/or only others approved by the Board so to do. Only expenditures within the budget shall be made.

The Manager shall at all times make and collect such charges for the use of said Airport and its facilities as may be fixed and determined by the Owner or by any State or Federal agency having jurisdiction thereof.

The Manager shall at all times keep and maintain the runways, taxiways and parking ramp free and clear of any accumulation of dirt, debris, ice, snow or other matter tending to interfere with their safe and proper use; shall assure that the runway and taxiways are properly lighted; that the approach lights, NDB, and all other aviation equipment is properly operating and maintained; public use and shall keep the waiting room and all other areas and their appurtenances in proper condition for the others passengers, visitors and accommodation οf rightfully upon the premises, and shall keep and maintain all the premises free and clear of any growth of weeds, grass, sprouts, bushes, dumps, garbage and/or other matter of similar or dissimilar character tending to render said premises unsightly, unsanitary or unsafe for use airport.

For and in consideration of its services in operation of said Airport, the Owner agrees to pay Manager a fee of ten dollars (\$10.00) and other considerations for

the term of the contract.

This agreement shall in no way be construed as to negate or contradict any F.B.O. Contract or Lease Agreement that may be in force during the tenure of this contract and where inconsistent therewith, said Contract or Lease Agreement shall prevail.

All copies of Purchase Orders, books of account and financial records pertinent to the operation of the Airport shall be properly maintained and shall at all times be available for inspection by a properly authorized auditor and/or Owner designee.

This agreement may be terminated by either party upon thirty (30) days' written notice to the other of an intention to terminate and either party may cancel this agreement on thirty (30) days' notice in writing for any default on the part of the other in carrying out the terms hereof.
